#### **SECTION 4 - FIRST AID MEASURES**

#### **SECTION 5 - FIRE FIGHTING MEASURES**

<u>Suitable Extinguishing Media:</u> Use dry chemical, foam, carbon dioxide, or water fog to extinguish fire. Water may not be effective to extinguish fire. Spattering of flammable liquid may result from spraying water.

<u>Specific Hazards arising from the Chemical</u>: Minimize breathing gases, vapors, fumes or decomposition products. at elevated temperatures, vapors can form an ignitable mixture with air. Material will accumulate static charges which may cause an electrical spark (ignition source), bond and ground containers when transferring material. Use spark-proof tools and explosion-proof equipment. Do not reuse containers without proper cleaning or reconditioning.
